### Annex 1 - Mandatory conditions

### Premises Licence, Films permitted

The admission of children under the age of 18 to film exhibitions permitted under the terms of this licence shall be restricted in accordance with any recommendations made

a. By the British Board of Film Classification (BBFC,) where the film has been classified by that Board,
or

b. By the Licensing Authority where no classification certificate has been granted by the BBFC, or, where the licensing authority has notified the licence holder that Section 20 (3) (b) (74 (3)(b) for clubs) of the Licensing Act 2003 applies to the film.

## Annex 2 – Conditions consistent with the Operating Schedule Embedded Restrictions

#### Entertainment

The appropriate sections of the Regulations and Conditions for Entertainment Licences dated August 1996 issued by Reigate and Banstead Borough Council apply.

The following special conditions also must be adhered to:-

For the purpose of regulated entertainment the maximum number of persons to be admitted shall not exceed 120

# It is the responsibility of the person named on the licence to ensure that the hall is safe to use for the licensed activities and is used safely. The licensee must:

- ensure that a copy of the licence, the licence conditions and the instructions to be followed in case of an emergency are prominently displayed on the premises and drawn to the attention of hirers, preferably in writing;
- ensure that either a member of the management committee or the hirer of the premises is responsible for both the entertainment and the safety arrangements when the premises are used for public entertainment;
- ensure that the premises are inspected before each performance and that all escape routes are kept clear, all exit doors open easily, all the fire extinguishers are charged and in place and that warning and emergency escape lighting systems (if installed) are working;
- ensure that attendants/stewards are given instructions on their essential responsibilities in case of fire or other emergency;
- ensure that storage areas (e.g. under-stage areas, rooms, basements, etc) which may contain combustible materials or flammable substances are lined with fire resisting materials.
- naked flame, smoke machines, lasers, pyrotechnics and firearms (imitation or otherwise) are NOT to be used without prior approval of the local authority
